Regulations for the use of electric car charging stations in the parking lot of Hotel Platan and Zacisze Restaurant in Gdańsk

§1

1. These regulations ("Regulations") define the rules of using the electric car charging station

electric cars, located in the parking lot of Platan Hotel and Zacisze Restaurant, ul. Niepołomicka 36, 80-180 Gdańsk ("Parking").

2. The Regulations have been established by ELKOMPLEX Andrzej Jarząbkowski, which owns and operating the services of the Hotel Platan accommodation facility and the catering facility Restaurant Zacisze, 36 Niepołomicka St., 80-180 Gdańsk, tel: 58 717 86 00 ("Hotel", "Restaurant").

The Regulations may be amended at any time.

3. There is one (1) marked charging station for electric cars on the premises of the Parking Lot

with two (2) outlets, each including technical infrastructure and a

dedicated parking space for setting up the car ("Charging Station").

- 4. The Regulations shall apply to all persons using the Charging Station. Persons and vehicles driven by them that violate the provisions of the Regulations may be removed by the Hotel and Restaurant from the Charging Station.
- 5. Each person using the Charging Station agrees to the provisions of the Regulations,

undertakes to comply with them and shall be liable to the Hotel and Restaurant for

compliance with the Regulations.

§2

1. Use of the Charging Station is allowed 24 hours a day on all days of the week.

2. Charging stations are intended exclusively for charging electric cars, i.e. cars with electric motors i.e. electric cars and may not be used for parking of cars or other vehicles.

3. Charging of the vehicle along with payment of fees is done through the Elocity mobile application. Hotel and Restaurant do not charge for the use of the Station.

§3

The basic rules of using the Charging Station include:

1. Using the Charging Station only while charging the car.

2. Independent connection of the plug of the Charging Station to the car by the person driving the car.

3. Absolute prohibition of using the Charging Station by:

a. Cars carrying flammable, corrosive, explosive materials and other similar

materials and substances that may create a danger to persons and property,

b. Cars whose purpose would be to conduct commercial activities in the Parking Lot.

c. Cars with internal combustion engines only.

4. Prohibition of leaving animals in the car on the premises of the Charging Station.

5. Setting the car on the territory of the Charging Station, immobilizing it, turning off the engine and lights, closing windows, doors and luggage, lights, closing windows, doors and trunk.

6. Self-protection of the car against theft or burglary by the person driving the vehicle.

in question.

7. Leaving the plug of the Charging Station after completion of charging in a place intended for this purpose designated place.

§4

- 1. Any interference with the technical infrastructure of the Charging Station is prohibited.
- 2. Any irregularities in the operation of the Charging Station, as well as in the case of doubts as to the use of the Charging Station should be reported to the staff of the Hotel or Restaurant Zacisze staff.

§5

The Manager shall not be liable:

1. For the consequences of using the Charging Station contrary to its purpose or the Regulations.

2. For any interruption in the operation of the Charging Station or the application required to use of the Station. Any of the Charging Stations may be at any time, temporarily or permanently, shut down from operation.

3. For any damage caused by force majeure, theft (burglary, robbery

etc.), destruction or damage to the cars located on the premises of the Charging Station, as well as to the items left in them or constituting their equipment.

4. For the effects of third parties.

- 1. In case of violation by the user of the provisions of the Regulations, the Hotel and Restaurant may apply measures necessary to restore the state of compliance with the Regulations, including by removing the car from the Charging Station, or applying a mechanical lock on the car of the car.
- 2. In cases referred to in paragraph 1, the user of the car shall be obliged to cover costs associated with the removal of the car from the Charging Station and its protection and storage until the car is collected by the user by paying a fee in the amount of PLN 500.
- 3. The user shall be liable for any damage caused by the vehicle or arising in connection with the use of the Charging Station.
